Minutes from Regular Church Conference held Sunday, August 17, 2025

Moderator: Nick McClellan, Senior Pastor

- 1) Called into Conference by Pastor Nick McClellan.
- 2) Minutes of the May 18, 2025, Regular Business Meeting were presented and approved by motion, second, and vote.
- 3) Jim Adams, Chairman of the Deacons, was recognized for presenting a slate of men selected through the recent nomination process (May 2025). The Deacons, as a body, have recommended that six (6) men duly nominated to the office be invited to join in serving as Deacons. Included are the following men:

Coming from a committee, the recommendation does not need a second. A vote of affirmation was held, resulting in a clear passage.

- 4) Brian Gannon, Chair of the Nominating Committee, was recognized to review the completed nominating report (available in the sanctuary and at www.BrushyCreek.family). Standing committees, ad hoc committees, leaders in Children and Youth, as well as Sunday School teachers. The report also includes the current listing of Church staff.

Coming from a committee, the recommendation to accept the report does not need a second. A vote was held, and the yes carried.

- 5) Finance Committee Chairman Nathan Parker was recognized. On behalf of the Finance Committee, he provided a brief report indicating that, as of the end of July 2025, giving was running slightly behind, which is typical for summer months. He also noted that the balance on the Worship Center renovation debt was now below \$200,000.
- 6) Jimmy Sanders, Operations Pastor, was recognized for updates on various projects. Renovations of a children's classroom are proceeding with volunteer labor at the Church. Concrete has been poured for the elevator at CLC, and work on the steel structure is expected to begin within a week. Work should be completed near year-end. The Pavilion is currently going through the permitting process.
- 7) Pastor McClellan provided a brief Pastor's Report. He encouraged the Church to continue giving toward these projects so that work can be completed without debt if possible. A full report on campus projects will be provided in the coming months.
- 8) A motion to adjourn the meeting was made and seconded. Approval of the motion was unanimous.
